Even better, your gift qualifies for your required minimum distribution (RMD).

HERE ARE SOME OF THE WAYS YOU CAN BENEFIT FROM AN IRA ROLLOVER GIFT THIS YEAR:

Reduce Your Taxable Income.

By rolling over some or all of your RMD from your IRA to the Orange Catholic Foundation, you can reduce your taxable income this year.

Lower Your Social Security Tax.

Reducing your taxable income with an IRA rollover gift may also reduce the tax due on your social security payments.

Avoid IRS Tax Limits.

IRA rollover gifts may be made over and above the normal cash gift limit (60% of your adjusted gross income).
